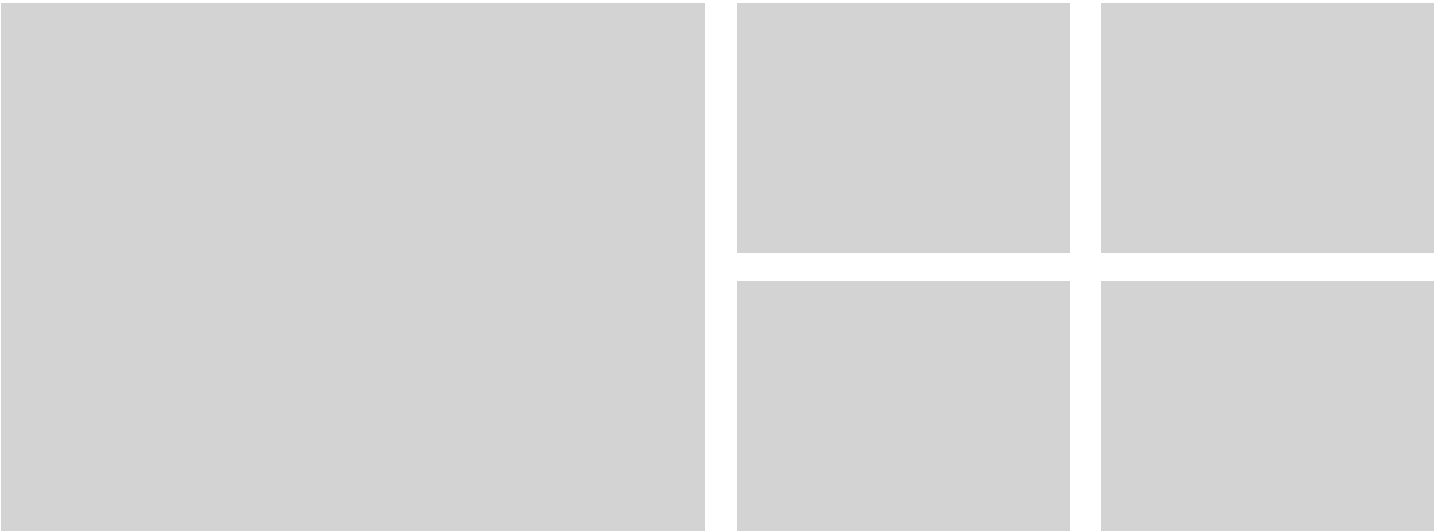

The total amount of repayments has been calculated by multiplying 208 weekly repayments (based on a 48 month term) by the weekly repayment amount of \$85.91 which equals \$17,870.16.
